Overview of Zydus Medical College and Hospital, Dahod

- To establish world class institute of medical education and to train, in a spirit of collegiality with a standard of excellence, outstanding clinicians and innovative and human leaders in medicine and science.
- Zydus Medical College and Hospital (hereinafter referred to as 'ZMCH' or 'hospital' or 'college') is a self-financed brownfield medical college and hospital established in 2017 in Dahod district, Gujarat.
- It intends to serve the tribal and underserved populations of eastern Gujarat, as well as nearby districts of Madhya Pradesh and Rajasthan.
- It was developed in a Public Private Partnership (PPP) with the Government of Gujarat and Zydus Foundation under the Health Policy, 2016 of Gujarat Governments.
- The campus comprises of a medical college spread across 80,937 sq.m. of land and hospital set up over an area of 58,033 sq.m.
- The college is known to be the 1st medical college in the district and the 1st batch of MBBS programme was commenced in 2018.
- Since the establishment of the college, 550 students have enrolled in the MBBS programme, and has initiated 50 research initiatives.



Rationale of the study

To undertake social impact assessment of CSR initiative being implemented by Zydus Foundation – establishment and financing of ZMCH, Dahod in accordance with CSR Rules.

Results

Relevance: Zydus Foundation's initiative is relevant to the needs of the local population

Relevance

- Dahod is one of the most backward districts with a large tribal population.
- As per Rural Health Statistics 2015, Dahod had one (1) district hospital, one (1) sub-divisional hospital, thirteen (13) Community Health Centres and eighty-five (85) Primary Health Centres.
- As per the Audit Report (General and Social Sector)
 for the FY 2014-15, the bed strength of District
 Hospital Dahod was 150 against required bed strength
 of 440 as per Indian Public Health Standards
 (IPHS). Furthermore, audit had observed serious
 inadequacies in the infrastructure of the District
 Hospital Dahod hampering service delivery.

Inference

- Inadequate healthcare infrastructure and poor healthcare indicators in the target geography necessitates healthcare intervention.
- The establishment of a brownfield tertiary care hospital and medical college is highly relevant to the needs of the local population.

- The 3rd SDG intends to achieve 'Good Health and Wellbeing for All'.



 Zydus Foundation's ongoing initiative of running Zydus Hospital is effectively aligned with the indicators described under SDG-3 by the UN. It showcases commitment of the foundation towards contributing to global efforts to achieve health and wellbeing for all

Effectiveness: Alignment with national health policy and programs

Effective Coherence with National Programs

- ZMCH supports implementation of various national healthcare programmes such as the National Programme for Control of Blindness (NPCB), Revised National Tuberculosis Control Programme (RNTCP), Setting up Nutritional Rehabilitation Centres (NRC)
- It has also an established Centre for the screening of thalassemia and sickle-cell anameia

Effective alignment with National Health Policy, 2017


- The National Health Policy 2017 emphasizes strengthening health systems, building health infrastructure in accordance with Indian Public Health Standards (IPHS), and reducing out-of-pocket expenditure.
- Efforts of Zydus Foundation are directed at achieving the above-mentioned objectives effectively. The hospital bridges the gaps in healthcare infrastructure in the Dahod District and free of cost treatment eliminates out- of-pocket expenditure completely.

Effectiveness: Effective coverage of beneficiaries

Effective Coverage of Beneficiaries

- Selected beneficiaries comprised 42% females and 58% males, across age groups with an average age of 40 years
- Average monthly family income of the beneficiaries was observed to be INR 9,100 which is lower than minimum wages.
- Approximately 64% of the respondents had a monthly family income of less than INR 10,000.
- Inference: Effective and targeted coverage of beneficiaries from low-income groups.

Monthly Family Income of Beneficiaries




Effectiveness: Quality of services


Effective Delivery of Quality Services

- 61% beneficiaries have been visiting Zydus Hospital for less than 6 months and 4% of them have been visiting for more than 3 years
- Nearly 50% of the respondents visit Zydus Hospital for every health-related problem
- Responsiveness: 54% of the beneficiaries have reported that the doctors of the hospital are highly prompt in attending them and takes 15-30 minutes to see the doctor
- Medical Facilities: 71% of selected beneficiaries were 'very satisfied' with the medical facilities that are provided by the ZMCH
- Behaviour and qualification of the medical staff: 75% and 71% of selected beneficiaries are 'very satisfied' with the behaviour and qualification of the medical staff of the Hospital, respectively
- Hospital cleanliness and maintenance: 74% of selected beneficiaries are 'very satisfied'. This has resulted in a 100% recommendation by the beneficiaries to their friends and family for any treatment.

Satisfaction rate of selected beneficiaries with medical facilities of Zydus Hospital




Effective Delivery of Quality Services

 Medical Attention: 95% of the beneficiaries are highly satisfied by the medical attention offered by medical professionals of the hospital and 97% have reported that it takes less than 24 hours for them to receive their medical reports, depicting a high turnaround-time (TAT)

Effectiveness: Affordable and accessible services

Accessibility and Affordability

- Hospital is visited by beneficiaries from various strata of the society and varied geographical locations
- Accessibility: Nearly 65% of the beneficiaries need to travel less than 30 km to reach the Zydus Hospital and 35% of them are required to travel more
 than 30 km
- Affordability: All the services provided by the hospital are free of cost, expect the expense for implants and CT scan which are lower than those of comparable government hospitals.
- Beneficiaries have highlighted that in absence of Zydus Hospital, they would have to visit other primary and secondary-level healthcare facilities or private healthcare facilities which are expensive, inadequately equipped, and are located at large distance. This highlights the affordability and accessibility of Zydus Hospital which it has offered to the local community.



Impact: Enhancement in healthcare infrastructure

Impact on Healthcare Infrastructure

- Zydus Foundation's initiative of building Zydus Hospital and Medical College in Dahod has a significantly improve healthcare infrastructure.
- Findings and Observations described in the Audit Report (General and Social Sector) for the year ended 31 March 2015 have been taken as a baseline for comparison.

Inference

 It is evident Zydus Foundation has positively impacted healthcare infrastructure in the Dahod District.










Impact on Healthcare Service Delivery


- Since inception, Zydus Hospital has served the community and provided adequate healthcare facilities.
- Total OPD footfall during the assessment period (April 2018 to March 2021) was 7,62,347.
- Total surgeries: 16,260 surgeries were performed during this period (April 2018 to March 2021).

Impact: Community outreach

Impact of community outreach activities

- Hospital and community medicine department of the medical college undertake several community outreach programmes to provide disease prevention and health promotion services.
- Various outreach programmes being conducted are:
 - ✓ Diagnostic and Health Awareness Camps
 - ✓ School Health Programme, Anti-Malaria Month Celebration
 - ✓ Breast Feeding Week Celebration
- Hospital has also adopted a Rural Health Centre and an Urban PHU to provide quality primary and referral services.

Family Adoption Programme

- It is an innovative and unique initiative undertaken by the ZMCH.
- Each medical student adopts five (5) families.
- Medical students are responsible for managing health and other cross cutting aspects of the adopted family.
- This initiative helps in building rapport of medical students with the community, understanding challenges of public health, and augmenting health seeking behaviour of the community.
- Till date around 20,000 families have been adopted by medical students.


Impact: COVID-19 Pandemic

Impact on COVID-19 Pandemic

- ZMCH has established a separate OPD and IPD facilities for COVID-19 management.
- OPDs are equipped with Rapid Antigen Testing and RTPCR sample Collection facilities.
- Dedicated radiology and blood gas analysis service are also available.
- Total of 300 separate beds are available for COVID -19 management and over 200 beds have central oxygen supply.
- Hospital has two (2) oxygen plants with 13kld capacity which suffices the need of the hospital.

Financial Sustainability

Sustainability

- The ZMCH has been established under Gujarat Government's Health Policy 2016 as a brownfield hospital. Major sources of funding are:
 - o Annual Grant from Government of Gujarat: INR 8.5 Crore for five years
 - o Annual Student Grant from Government of Gujarat: INR 15 Crore for five years
 - CSR Donations: INR 200 Crore
 - NCD Issued by Zydus Group at notional interest rate: INR 185 Crore
- In addition, tuition fees from medical students and reimbursements from PMJAY are other sources of revenue.
- The hospital and medical college faces annual revenue gap of INR 30-35 crore. Furthermore, annual grant from the government of Gujarat will support till FY 2023 only.
- To ensure sustainability of the project, following sources of funds can be explored:
 - Increase coverage under PMJAY
 - Mobilization of CSR funds from other corporates
 - o Mobilization of grants and aids from international NGOs
 - o User Charges for certain category of patients on some services
- To enhance medical services to serve the community, the hospital will be undertaking establishment of a few super-speciality services in addition to existing services over the course of time

Conclusion

Conclusion

- Zydus Hospital and Medical College was established under Gujarat Government's Health Policy 2016, as a brownfield project and it is run by Zydus foundation
- The major sources of funding includes CSR contribution from Zydus Group, Grant from Government of Gujarat, reimbursements under PMJAY, and tuition fee of medical students.
- Hospital services include all broad specialities and some super-specialty services.
- All the services provided by the hospital are **free of cost**, except the expense for implants and CT scans which are **lower than those** of comparable government hospitals.
- Zydus Foundation's ongoing initiative of running Zydus Hospital is effectively aligned with the indicators described under Sustainable Development Goal (SDG) -3 by the United Nations and National Health Policy 2017
- Hospital caters to patients from Dahod, Panchmahal, Mahisagar, Chhota Udaipur, Alirajpur, Jhabua, Banswara, and Dhar districts, which are
 predominantly tribal and backward areas which illustrates effective coverage of beneficiaries
- As per the beneficiary survey, the majority of respondents are highly satisfied with the quality of services provided.
- Furthermore, the hospital undertakes innovative community outreach initiatives for health promotion and disease prevention.
- The hospital also supports various national health programs such as RNTCP, NRC, and NPCB. Efforts of the Zydus Foundation will lead to significantly improving healthcare indicators of the Dahod and nearby districts.
- ZMCH has positively affected healthcare infrastructure and service delivery in the tribal district of Dahod.
